## ENROLMENT PROCEDURES

## Timeline

#### For Kinder/New Enrolment Applications

- Submit COMPLETED application with all required documentation to the school office. Please note original supporting documentation is required to be shown at this time. Paperwork to be submitted by Friday 9<sup>th</sup> April.
- 2. Office staff will contact you to arrange an interview time for you and your child with the Principal. (conducted from early Term 2)
- 3. Enrolment Committee responds to all applicants with offers of placement or waiting list (end of June)
- 4. Parents will be invited to attend an Information Evening in Term 4.
- 5. Children will visit the school for Orientation Mornings in Term 4. A letter will be posted later in the year with further details.

	Enrolment Application (Form A and B) – <b>BOTH</b> parents must sign the forms
	Full Birth Certificate – not extract (original to be sighted at lodgement)
	Baptism Certificate (original to be sighted at lodgement)
	Proof of Residence required at lodgement (latest rates/water notice, driver's licence)
	<u>Copies</u> of all medical and specialist reports pertaining to your child including speech therapy, paediatric reports etc
	A current photo of your child (passport size, etc)
	Up-to-date Immunisation Forms (this can be printed from the government website)
	Passport & Visa (this is required if <b>child or either parent</b> are born overseas or non-Australian citizen.
	Citizenship Certificate (if child or either parent are born overseas)
	Your child's latest School Report/Naplan Report (Years 1-6)

#### Sibling Discount on Diocesan Tuition fees

Sibling discounts apply to Diocesan Tuition Fees and are included above at 25% discount for the second child, 50% for the third child and 100% for the fourth and subsequent children attending Catholic systemic schools in the Diocese of Parramatta, Archdiocese of Sydney, Diocese of Wollongong, and Diocese of Broken Bay as well as at St Dominic's College, Kingswood. In addition, principals have the discretion to give a discount of up to 10% on the total diocesan tuition fee where there are siblings attending congregational schools and the principal believes that the financial circumstances of a given family warrant some reduction. #### **Diocesan Building Levy**

All families with one or more children in a Parramatta Diocesan School or at St Dominic's College, Kingswood are required to pay the annual Diocese of Parramatta Diocesan Building Levy. This levy has replaced the various building levies that parents previously paid to school building funds (managed by either parishes or schools). The levy for 2020 is \$822 per family, payable in three equal instalments of \$274 payments in terms one, two and three.

#### Diocesan Temporary Residents Education Fee (DTREF) - 2020

The DTREF for 2020 is **\$2,016 per student, payable in three equal instalments of \$672.** The fee applies to new students on the following Visa numbers: 173, 400, 401, 402, 405, 407, 408, 410, 411, 415, 416, 417, 420, 456, 457, 462, 476, 482, 485, 580, 590, 600, 601, 651, 771, 884, 944, 956, 976 and 977 including where any of these are the preceding visas for families on bridging visas 010 to 090. Families charged this fee in 2013 will continue to be charged on a per family basis to the eldest student whilst the family has continuous current students.
